Independent Auditor's Review Report on the Third Quarter and Nine Months Unaudited Financial Results of the Company Pursuant to the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended

TO THE BOARD OF DIRECTORS OF SWADHA NATURE LIMITED (FORMERLY KNOWN AS MS SECURITIES LIMITED)

1. We have reviewed the accompanying Statement of Unaudited Financial Results of Swadha Nature Limited (Formerly Known as MS Securities Limited) ("the Company"), for the third quarter and nine months ended December 31, 2024 ("the Statement"), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
